Due to the high cost of maintaining instruments and protecting them from loss or damage, students who use district-owned instruments are encouraged to purchase insurance to cover the instrument against loss or accidental damage. The cost to rent a district owned instruments is \$50.00. The rental fee is used to help defray the repair costs for normal wear on the instrument. The \$50.00 rental fee DOES NOT cover theft, neglect or abuse of the instrument. Students and parents may be held liable for damage or loss of the instrument due to neglect or carelessness.
